

- Care Cash® helps employees pay toward costsharing for certain eligible network health care expenses and encourages them to use quality care. This preloaded debit card can be used for UnitedHealth Premium® provider visits as well as network primary care provider visits, 24/7 Virtual Visits, urgent care visits and outpatient behavioral health visits. Care Cash is only available with select plans. Program availability excludes health account deposits (HRA, HSA).
