What is the overall deductible?	Network: \$0 Individual / \$0 Family	See the Common Medical Events chart below for your costs for services this plan covers.
Are there services covered before you meet your deductible?	Yes.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible. Are there other deductibles for specific services?	Yes, Prescription drugs - \$500 Individual / \$1,000 Family Deductible does not apply to Tier 1 and Tier 2 drugs. There are no other deductibles. ### Does this plan provide Minimum Essential Coverage? Yes.

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
