What is the overall deductible?	Network: \$0 Individual / \$0 Family	See the Common Medical Events chart below for your costs for services this plan covers.
Are there services covered before you meet your deductible?	Yes.	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible. Are there other deductibles for specific services?	Yes, Prescription drugs - \$4,500 Individual / \$9,000 Family Deductible does not apply to Tier 1 and Tier 2 drugs. There are no other deductibles. What is the out-of-pocket limit for this plan?	Network: \$9,200 Individual / \$18,400 Family	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan, they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.

Do you need a referral to see a specialist?	Yes.	This plan will pay some or all of the costs to see a specialist for covered services but only if you have a referral before you see the specialist.

- Infertility treatment
- Long-term care
- Non-emergency care when traveling outside the U.S.
- Routine foot care - except as covered for certain diseases
- Weight loss programs

- Bariatric surgery
- Chiropractic (manipulative) care - 20 visits/year

### Does this plan provide Minimum Essential Coverage? Yes.

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.

### Does this plan meet the Minimum Value Standards? Not Applicable.
