What is the overall deductible?	\$0	See the Common Medical Events chart below for your costs for services this plan covers.
Are there services covered before you meet your deductible?	No	You will have to meet the deductible before the plan pays for any services.
Are there other deductibles for specific services?	Yes, Prescription drugs - \$500 Individual / \$1,000 Family Deductible does not apply to Tier 1, Tier 2, Tier 3 and Tier 4 drugs. There are no other deductibles.	You must pay all of the costs for these services up to the specific deductible amount before this plan begins to pay for these services.

### Does this plan provide Minimum Essential Coverage? Yes.
